#### ORDER IN RE: PUBLIC HEARING ON REDISTRICTING OF WARDS

WHEREAS, the Board of Trustees of the South Tippah School District previously declared its intention to hold the required public hearing on the new proposed voting district lines under the redistricting plans as drafted and prepared by Northeast Mississippi Planning and Development District; and

WHEREAS, legal notice of the public hearing was run in the Southern Sentinel, Inc., a weekly newspaper having a general circulation in the City of Ripley, Tippah County, Mississippi area, for the time and manner required by law; and

WHEREAS, as directed in the Notice of Hearing, the Chairman, Kerry Cockrell, duly called the public hearing convened for the Board of Trustees of the South Tippah School District to hear any comments on the proposed redistricting plan for the South Tippah School District; and

WHEREAS, Mr. James Storey, Mrs. Brenda Storey, Mr. Willie Johnson, Mr. Sammy Lee Rutherford and other citizens appeared before the Board to offer comments on the proposed redistricting plan. No negative comments were made. Chairman Cockrell thanked each person for their attendance and comments.

NOW, THEREFORE, upon motion duly made by Trustee Nicole Bullock, seconded by Trustee Tim Clark and unanimously adopted, it is hereby ordered as follows:

- (1) The public hearing of the proposed redistricting plan of the South Tippah School District pursuant to the 2020 Census of the United States of America, as proposed and drafted by the Northeast Mississippi Planning and Development District, was held, after legal notice to the general public, in the time and manner required by law, with all comments being noted and no objections to the proposed redistricting plan being presented.
- (2) The Northeast Mississippi Planning and Development District, Superintendent, and Attorney for the Board, are further authorized and directed to take other steps, as necessary, at this time to proceed with the finalization of the proposed redistricting plan for the South Tippah School District.
